DECISION AND ORDER OF THE BOARD DELIVERED BY S.W. LEE AND K. HUSSEY AT THE FIRST PRE-HEARING CONFERENCE

- [1] This is the first and probably the only pre-hearing conference ("PHC") in these matters. This PHC follows two case management meetings with the Ontario Municipal Board ("Board") to design a hearing process that can be at once simple and labyrinthine. As a result, these proceedings, involving the Development Charges ("DC") By-laws of three municipalities have not been consolidated. In fact, they remain as separate and distinct files. The Board directs that these appeals will be heard together in order to lend efficiency to the hearing process. In addition, such an approach will avoid the possibility of conflicting findings where common issues are involved.
- [2] Common to these appeals is a dispute involving the legitimacy of a chosen methodology in the Background Studies in the DC calculation for these three municipalities. At the heart of it is the question whether a methodology based on the combined population-based and household-based approach is acceptable within the permitted purview of the *Development Charges Act*. These disputes have arisen as the aftermath of the Board decision in *Orangeville v. District Home Builders Association* File No. DC090049 rendered by the same panel, which decision had been subsequently upheld at the Divisional Court (*Orangeville District Home Builders Association v. Orangeville* (Town), [2011] O.J. No. 1393 (Div. Ct.).
- [3] The Board will set the following hearing dates for two separate phases:
 - 1. Phase 1: October 20, 2014 to November 7, 2014, inclusive, addressing the methodology disputes for the DC By-laws for the City of Markham, the Municipality of Clarington and the City of Mississauga. As well, this phase will address the associated disputed matters of the Municipality of Clarington. All parties to these appeals will participate at this phase.

- 2. Phase 2: December 1 12, 2014, inclusive, addressing the disputes unique to the City of Mississauga. The clients of Mr. Howe, Ms. Rosenthal and Mr. DeMelo will participate at this phase.
- 3. These proceedings commencing at **10 a.m.**, will be held at:

Phases 1 and 2 can be heard by separate panels.

- [4] The Board directs the parties to prepare for a hearing process that will focus on only what is disputed. Where there is commonality, the parties should admit them either as a fact or as a concept and reveal it to the hearing panels. Where appropriate, simple sample calculation should be used for the purpose of illustrations and explanations. The Board also trusts that the parties will work out the issues list and exchange dates and can issue the requisite orders on consent.
- [5] The Board so orders.
