MEMORANDUM OF ORAL DECISION DELIVERED BY M.A. SILLS ON AUGUST 26, 2020 AND ORDER OF THE TRIBUNAL

- [1] This was the first Case Management Conference ("CMC") in the matter of appeals by Amacon Development (City Centre) Corp., and College Mississauga Holdings Ltd. from the passing of Development Charges By-law No. 1196-2019 (the DC By-law").
- [2] The DC By-law passed by the City of Mississauga (the "City") on June 16, 2019, imposes development charges on the development of all lands within the geographic boundaries of the City.
- [3] A draft Procedural Order ("PO") was provided to the Tribunal in advance of this CMC. In this regard, the Tribunal was informed that the parties have been and continue to be engaged in discussions in the preparation of the PO, as well as the discovery of opportunities for settling some or all of the issues in the appeals. Ms. Magi confirmed that the City does not have any concerns with the prepared Issues Lists.
- [4] The parties are requesting that a second CMC by VCC be scheduled in early February 2021, at which a settlement(s) or a final draft PO can be presented for the consideration and approval of the Tribunal.
