## <u>DECISION DELIVERED BY A. CHRISTOU AND ORDER OF THE BOARD</u>

This Pre-hearing Conference (PHC) by Teleconference (TCC) on April 26, 2011, relates to the appeals to the Rural Hamilton Official Plan ("Rural OP"), and it was specifically to discuss procedural matters with respect to those Parties previously identified as Groups:

- 4 Policy D.2.2.1;
- 5 Severance Policies and Related Definitions;
- 6 Schedule D (Modification 33b only);
- 8 Special Policy Area B; and
- 10 Special Policy Area C (Airport Employment Growth District).

At the start of the hearing, Ms Wice, Counsel for the City, advised the Board that the Parties have been discussing the various issues for Groups 4, 5 and 6, and believe that the hearing may last three weeks and requested it be tentatively scheduled for January 2012. A further PHC set for late August 2011 would be of assistance to the Parties.

Ms Wice also requested the Board direct the Parties in Group 6 to advise the City which lands their clients have specifically appealed. Counsel representing the Group 6 appellants agreed to provide this information to the City by June 20, 2011.

There was discussion on whether or not Group 8 should have a separate TCC and the parties agreed to have further discussions among themselves before the October 2011 PHC. They will advise the Board of any resolutions at that time.

Ms Smith advised there is a separate PHC for Silvestri Investments, in Group 10, on August 8, 2011.

Ms Wice advised that they are looking to start mediation proceedings for Group 5.

On consent of all the Parties, the Board sets the following:

- A PHC will take place on August 29, 2011, at 10:30 a.m., at the City of Hamilton, OMB Hearing Room #6, McMaster Learning Centre, 50 Main Street East, Main Floor, Hamilton Ontario.
- The hearing will start on Monday, January 30, 2012, at 10:30 a.m. at the City of Hamilton, OMB Hearing Room #6, McMaster Learning Centre, 50 Main Street East, Main Floor, Hamilton Ontario for 15 hearing days. Ms Wice is to confirm the venue and advise the Board and the Parties accordingly.

No further Notice is required.
