MEMORANDUM OF ORAL DECISION DELIVERED BY R. ROSSI ON FEBRUARY 25, 2013 AND ORDER OF THE BOARD

- [1] This was the fifth prehearing conference ("PHC") to deal with procedural matters pertaining to a series of appeals to the City of Mississauga's new Official Plan ("MOP"), which was adopted on September 29, 2010. At a previous February 2013 hearing, the Board provided its decisions in respect of some of the Orlando Corporation appeals, who remains a possible appellant to other MOP policies.
- [2] For administrative purposes, Kelly Yerxa, counsel for the City of Mississauga ("City"), informed the Board that a number of the parties have site-specific applications before the City that might trigger further appeals. In these instances, with particular reference to the appeals of Latiq Qureshi, Derry-Ten Limited and White Elm Investments Ltd., the appellants have agreed to consolidate those appeals with the inprogress appeals of MOP.
- [3] The appellants' counsels in attendance requested a number of dates from the Board in respect of these appeals. On consent, the Board will hold a further PHC call to update the Board on the progress of these matters on:
