MEMORANDUM OF ORAL DECISION DELIVERED BY JASON CHEE-HING ON MARCH 25, 2015 AND ORDER OF THE BOARD

[1] This is the first pre-hearing conference ("PHC") into these matters. Southlawn Developments Inc. ("Proponent", "Applicant/Appellant") has appealed the failure of the City of Mississauga ("City") Council to make a decision on its applications for an Official Plan Amendment ("OPA"), Zoning By-law Amendment ("ZBA") and site plan application for the subject property located at 732-784 Eglinton Avenue West and 4920 Mavis Road.

- [2] The proposal is to construct on the subject property, a residential development comprising 14 horizontal multiple dwellings and 650 apartment dwelling units within two towers of 19 and 24 storeys.
- [3] A number of residents from the area requested and received participant status in these proceedings. They are Rashid Jama, Kamel Allani, Heather Cripps, Sharon Palladino, and Fan Yang.
- [4] The Board was advised by the parties that they are involved in ongoing discussions with respect to the issues. The City advised that they have recently forwarded comments to the proponent on its applications. The Board determined that it was premature to set a hearing date for these appeals at this time and would wait until the next PHC.
- [5] The Board set the next PHC to be held by a telephone conference call ("TCC") for **Monday**, **July 13**, **2015** commencing at **9 a.m.** at which time the parties will provide the Board with a status update on these matters. A draft Procedural Order is to be submitted at least seven days in advance of the next PHC. The parties shall call **(416) 212-8012** or Toll Free **1(866) 633-0848** at the correct time. - [6] No further notice is required.
