MEMORANDUM OF ORAL DECISION DELIVERED BY R. ROSSI ON APRIL 2, 2015 AND ORDER OF THE BOARD

- [1] The Applicant/Appellant, Yorkdale East Developments Ltd. ("Appellant") has appealed to the Ontario Municipal Board ("Board") the failure of the City of Toronto to make a decision on its Zoning By-law Amendment ("ZBA"), which seeks to rezone the subject property to a site specific zoning that would permit, in the proposal's current iteration, a 49-storey mixed use building fronting onto Bloor Street East and a 12-storey residential building fronting onto Selby Street with a one-storey link.
- [2] MTCC 1021, represented by Counsel Ron Kanter, was made a party to these proceedings now reflected in the Title of Proceedings above. The following entities were accorded participant status at the pre-hearing:
- [3] MTCC 1380 and Bloor Street East Neighbourhood Association Inc., represented by their agent Linda Brett (Ms. Brett will undertake to furnish the Board with a letter from the condominium board as soon as possible confirming her authority to represent it);
- [4] 505896 Ontario Limited, represented by Counsel James Quigley, will be permitted to seek party status once it advises the Board via e-mail as to the level of its intended participation and is dependent on that level of participation as stated at the hearing;
- [5] Upper Jarvis Neighbourhood Association, represented by its agent, association president (and owner of the property at 11 Selby Street) Brian Bagley. The Board advised Mr. Bagley to inform the association that it should incorporate itself for this and future appearances before the Board; and
- [6] Capreit, represented by its agent, Trish MacPherson.

[7] The Appellant's Counsel Kim Kovar advised the Board that a revised proposal

has been submitted to the City for review and evaluation. Ms. Kovar endeavours to

share that revised proposal with the other parties and participants as soon as

practicably possible. City Council is expected to review the Appellant's revised proposal

at its future July 7, 2015 meeting. City Counsel Mark Crawford anticipates receiving

instructions from City Council thereafter and the parties then requested a second pre-

hearing conference, which will be used either to inform the Board's hearing process

going forward or be used as a settlement hearing.

[8] The parties have requested the second pre-hearing conference to be held on

July 16, 2015. Given that the Pan American Games will be in progress in the City at

this time, the parties consented to holding this second pre-hearing conference as a

teleconference call to avoid travel congestion. The Board has invited the parties and

only those participants listed above to join in that call.

[9] On consent, the next teleconference call will take place at **9:30 a.m.** on
