## MEMORANDUM OF ORAL DECISION DELIVERED BY HELEN JACKSON ON NOVEMBER 22, 2017 AND ORDER OF THE BOARD

[1] This matter relates to the appeals by 675553 Ontario Ltd. (the "Applicant") of the failure of the City of Mississauga (the "City") to make a decision on applications for a draft plan of subdivision, removal of a holding symbol, and site plan approval for a redevelopment proposal at 90, 100 and 110 Dundas Street West. The appeals of the draft plan of subdivision and the removal of a holding symbol have been withdrawn, and the only appeal that remains is the referral of the site plan approval.

[2] The Applicant indicated that they have been working diligently with the City to address all of the items requiring resolution, and are in the process of providing a third submission to the City. Anticipating that the City would require four to six weeks to review this submission, the Applicant requested a hearing date in seven to eight weeks to address any matters that cannot be resolved.

- [3] Given the unknown number of hearing days that would be required, the Applicant and the City agreed to a further Telephone Conference Call ("TCC") in about two weeks' time, at which point, the Parties will be in a position to determine the number of hearing days required. The Board agreed to set a further TCC for the purpose of setting hearing dates.
- [4] The Board orders a TCC to be scheduled for **Thursday**, **December 7**, **2017 at 9** a.m.
