## DECISION DELIVERED BY SUSAN de AVELLAR SCHILLER AND ORDER OF THE BOARD

[1] This was the second prehearing conference ("PHC") for the appeals and referrals by 1077022 Ontario Inc., Touchtone Constructions Ltd., and Armdale Estates Inc. (together "Applicants") regarding the removal of a Holding symbol in By-law No. 0225-2007 and referrals of site plans. This is case PL160192.

#### **CONSOLIDATION OF APPEALS**

- [2] At the first PHC, the Board, differently constituted, was asked to consolidate these matters with the appeals by 1077022 Ontario Inc. and Touchtone Constructions Ltd. of the City of Mississauga ("City") Official Plan Amendment No. 8 ("OPA 8) and By-law No. 0050-2013 in case PL130350. Those matters are before the Board, again differently constituted.
- [3] The Board confirmed that the request at that first PHC was for consolidation in accordance with Ontario Regulation 30/02 of the *Ontario Municipal Board Act*, R.S.O. 1990, c. O.28 ("OMBA") and Board Rule 58 of the Board's *Rules of Practice and Procedure* ("Board Rules"). Counsel for the Applicants was clear that the request was for consolidation and not a request simply to hear matters together, as contemplated by Board Rule 59.
- [4] The request for consolidation was not a request to add the matters in case PL160192 to the appeals in case PL130350. Rather, the request was to separate out the appeals by the Applicants from PL130350 and consolidate them with PL160192.
- [5] Case PL130350 has several other appellants in addition to those appearing in PL160192.
- [6] No notice was given to the other parties in PL130350 of this request and no motion was brought in that case to separate out certain appeals.

- [7] The next appearance in case PL130350 was to have occurred a week after this appearance in case PL160192. At the request of the parties to that case, that appearance was adjourned.
- [8] With no notice having been given to the parties in case PL130350, and with the scheduled appearance in that case having been adjourned, the Board directed Counsel for the Applicants to obtain confirmation of consent or no objection from the parties to case PL130350 to the separation from that case of the appeals by 1077022 Ontario Inc. and Touchtone Constructions Ltd. to enable consolidation with the site-specific matters before the Board in case PL160192.
- [9] The Board has now been advised by counsel for the Applicants that all remaining parties to case PL130350 have provided consent or no objection to the appeals by the Applicants being separated out from the remaining matters in case PL130350 and consolidated with the site-specific matters before the Board in case PL160192.
- [10] Having been satisfied that sufficient notice of this proposed separation and consolidation has been given to the remaining parties, and with no party objecting, the Board now separates the Applicants' appeals in case PL130350 from that case and consolidates them with the Applicants' site-specific appeal and referrals in PL160192.

#### PHASING OF HEARING

[11] The Board understands that discussions are ongoing to determine if matters in either PL160192 or PL130305 may be resolved. To that end, the Board was asked and agreed to phase the consolidated hearing such that the issues for PL160192 will be heard and disposed of first. Following the disposition of matters before the Board in PL160192, the parties will advise the Board of the consequent status of matter in consolidated part of PL130350 and the Board will make such directions as it considers appropriate once such advice is received.

#### **PARTICIPANTS**

- [12] The Board heard from Gordana Djuricic, who presented a signed authorization to be the representative for a large number of the residents at 156 Enfield Place. The Board added these persons as Participants in these proceedings and notes their agreement that Ms. Djuricic will represent them and be the spokesperson for the group.
- [13] Several other persons attended the first prehearing and were added as Participants. Some of those added, at that time, are also residents at 156 Enfield Place. They were not included on the list of those to be represented by Ms. Djuricic although the Board understands that they may decide to have Ms. Djuricic represent and speak for them.
- [14] At that same first prehearing, some persons were added as Participants who do not appear to reside at 156 Enfield Place.
- [15] The list of those in each of these three categories is found at Attachment 1 to this decision.

#### HEARING DATE AND PROCEDURAL ORDER

- [16] At the first prehearing, the Board set down a three-day hearing to commence on February 21, 2017. The parties have filed a draft Procedural Order in this matter. The parties have since requested Board-led mediation and asked that the Procedural Order not be issued. At the request of the parties, the Board will not issue a Procedural Order. If the request for Board-led mediation results in any change to the hearing dates scheduled previously, the parties and participants will be notified.
- [17] I am not seized of these matters.

#### **ORDER**

### [18] The Board orders that:

- The site-specific appeals by Armdale Estates Inc., Touchtone
   Constructions Ltd. and 1077022 Ontario Inc. of City of Mississauga Official
   Plan Amendment 8 and of City of Mississauga By-law No. 0050-2013 are consolidated.
- 2. The Participants in these proceedings are set out in Attachment 1 to this decision.
