MEMORANDUM OF ORAL DECISION DELIVERED BY JOHN DOUGLAS ON DECEMBER 5, 2018 AND ORDER OF THE TRIBUNAL

INTRODUCTION

- [1] This was the first Pre-hearing Conference ("PHC") with respect to appeals by CRH Canada Group Inc. (the "applicant/appellant") of the failure of the Township of Tiny, under sections 22(7) and 34(11) of the *Planning Act* (the "Act"), to make a decision on applications for amendments to the Township's Official Plan (the "OP") and Zoning By-law (the "ZBL"). The purpose of these applications is to permit the expansion of an existing gravel pit for the subject property located at 2 Darby Road in the Township of Tiny.
- [2] As required, an application has also been made under the Aggregate Resources Act ("ARA"). At the time of writing of this decision, the referral of this matter by the Ministry of Natural Resources and Forestry ("MNRF") had not been received by the Local Planning Appeal Tribunal (the "Tribunal").

- [3] There is a copy of an Affidavit of Service for the provision of notice in the Tribunal's files. However, concerns with respect to the notice were discussed at the PHC. The applicant/appellant agreed to provide additional notice, upon direction by the Tribunal.
- [4] Judith Grant requested party status for the Federation of Tiny Township Shoreline Associations ("FOTTSA"), which is an umbrella group for 20 shoreline associations in the surrounding area. FOTTSA was granted participant status on consent. Ms. Grant did not have incorporation information available at the PHC, but has since advised the Tribunal that FOTTSA was incorporated on May 23, 1991 under Ontario Corporation Number 000936663.
- [5] A number of people requested and were granted participant status on consent: Jessica Staples-Campitelli; Bonnie Pauze; Erin Archer; Lynne Gibson; Balm Beach Community Association (Incorporation No.992157-5, spokesperson: John Campbell President); Rene Ariens; David Barkey; Mathew Lund; Don Morgan; Chris Williams; Peter Anderson; Nancy McBride; and Anne Ritchie Nahuis.
- [6] Four of the participants listed above indicated that they may seek party status at a future PHC. These individuals are: Bonnie Pauze; Erin Archer; Mathew Lund; and, Don Morgan. Any individuals that wish to seek party status should refer to the Tribunal's *Rules of Practice and Procedure*, and in particular Rule 8 Role and Obligations of a Party and Rule 10 Motions.
- [7] A second PHC by Telephone conference call ("TCC"), to be attended by the parties, has been scheduled to commence on **Friday, April 12, 2019** at **9 a.m.** The purpose of this TCC is for the applicant/appellant to advise the Tribunal on the status of the ARA application, specifically whether the referral of the ARA matter by the MNRF has been made. Individuals are directed to call **416-212-8012** or Toll Free **1-866-633-0848** on the assigned date at the correct time. When prompted, enter the code **4779874#** to be connected to the call. It is the responsibility of the persons participating
