## MEMORANDUM OF ORAL DECISION DELIVERED BY R.G.M. MAKUCH ON FEBRUARY 13, 2020 AND ORDER OF THE TRIBUNAL

[1] This is the third Case Management Conference ("CMC") respecting these appeals.

[2] The purpose of this CMC was to finalize the Procedural Order ("PO") and draft Issues List and to set hearing dates. Counsel for the City of Hamilton (the "City") had indicated that the City hoped to have discussions with Red Hill Cannabis Inc. (the "Appellant") on the issues to be adjudicated and that the scope of the appeal would be narrowed to a site-specific appeal. Counsel also indicated that there was the possibility of the City filing a motion seeking approval of the remaining portions of the zoning bylaw that are outside the scope of the appeal.

[3] Counsel for the City explained that the City has made a number of attempts to contact the Appellant in order to finalize a PO and Issues List without success.

[4] No one appeared on behalf of the Appellant.

[5] Counsel for the City has advised that the City will be bringing a motion in writing for an order of the Tribunal dismissing the appeals on the grounds that the Appellant has failed and/or refused to comply with directions from the Tribunal.

[6] In the alternative, the City will be bringing a motion to have the appeal scoped in order to have the amendments under appeal brought into force throughout the City save and except for the Appellant's property.

- [7] The Tribunal has directed that the motions be heard in writing.
- [8] This Member is not seized.
- [9] It is so ordered.
