MEMORANDUM OF ORAL DECISION DELIVERED BY C. HARDY ON SEPTEMBER 23, 2021 AND ORDER OF THE TRIBUNAL

[1] This was the second Case Management Conference ("CMC") with respect to the appeals by multiple parties under s. 17(24) of the *Planning Act* (the "Act") arising from the City of Toronto's ("City") adoption of Official Plan Amendment No. 445 ("OPA") implementing Site and Area Specific Policy 566 with respect to Queen Street West, City of Toronto.

[2] The Tribunal was advised that 2090416 Ontario Inc. et al, an Appellant in this matter, has entered into an Agreement of Purchase and Sale with 5042984 Ontario Inc. 5042984 Ontario Inc. attended the CMC as an observer.

[3] The Tribunal received one participant status request from Vera Frenkel who is a resident in the area. Ms. Frenkel did not attend the CMC, however the parties acknowledged receipt of her written request and raised no concerns. On that basis, the Tribunal granted participant status to Ms. Frenkel.

PROGRESS UPDATE

[4] The Tribunal was advised that the Estate of Frances Stein sold its property to the adjacent landowner, Jameson Plaza Ltd. The Tribunal did not receive formal notification of this transaction. Mr. Laskin undertook to confirm that his client would be assuming the status of the Estate of Frances Stein in this appeal and would advise the Tribunal in writing.

[5] Mr. Longo provided the Tribunal with an update on the status of the Issues Lists. He advised the Tribunal that discussions are continuing with Counsel for the parties in an effort to either resolve some appeals, or reduce the number of issues to be adjudicated.

[6] All parties at the CMC concurred with the City's submitted update.

[7] The parties requested that a follow-up CMC be set for February 2022 to allow Counsel the opportunity to continue discussions towards resolving or narrowing the issues or number of participants before the Tribunal.

[8] The Tribunal has scheduled a CMC to be held by video for Tuesday, February10, 2022 at 10 a.m.

[14] The Tribunal advised parties that Tribunal-assisted mediation is available if it would assist in narrowing issues or working towards settlement of any issues.

[15] The Tribunal orders that a third CMC is scheduled to commence at **10 a.m. on Tuesday, February 10, 2022**.

- [17] No further notice of the CMC is required.
